It covers specific commodities, including cattle, cocoa, coffee, palm oil, soy, wood, and rubber, as well as products derived from these commodities, such as leather hides, paper, and furniture.

Under this regulation, these products must be deforestation-free, meaning they must not originate from land deforested after December 31, 2020. EUDR deforestation assessments will be essential for businesses to ensure their products achieve EUDR compliance and reach their target market.

## Step 2: Advanced risk assessment

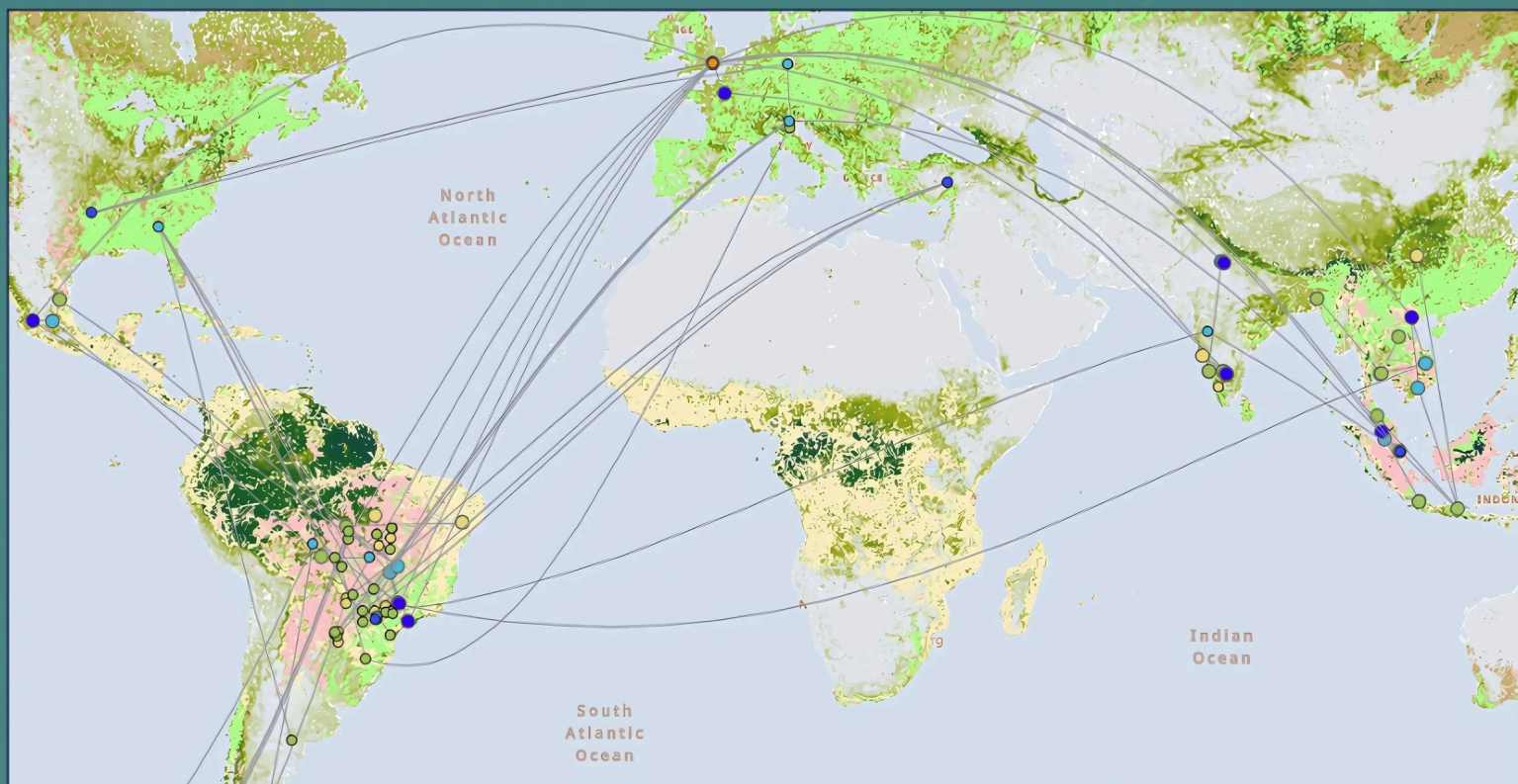

Where supply chains have been identified as non-compliant, or at risk of non-compliance, the company must undertake risk mitigation measures in accordance with Article 11 of the EUDR.
